Draft Proposed Program at a Glance

- Includes largest number of offshore leases ever proposed:
- 90% U.S. Ocean Waters
- Florida's Governor Rick Scott objected to new offshore oil & gas drilling and Interior Secretary Zinke said that Florida will be exempt and removed from the final plan. Subsequently, other Governors up and down the coast also voiced opposition and requested the same exemption as Florida. Since then, BOEM officials have stated that Florida is still included in the draft plan. The final outcome is still unknown



Scattered in the entire Atlantic Ocean, based on current estimates of recoverable fossil fuels there are: 229 days of oil and 477 days of gas (based on current U.S. consumption rates)

90% of U.S. Ocean Targeted for Drilling 2019-2024 Draft Proposed Offshore Oil and Gas Leasing Program

The administration is required to seek public comments for the Draft Proposed Program (DPP) and is also including scoping comments for the Programmatic Environmental Impact Statement (EIS).

What happens next?

Following the 60-day public comment period ending on March 9th the Proposed Program will be released, followed by a 90-day comment period. Then the Proposed Final Program will enter a 60-day review by congress prior to approval.



On January 4th. 2018 the Trump Administration's Secretary of Interior Rvan Zinke announced the next phase of President Trump's New Draft Proposed 5-year (2019-2024) Outer Continental Shelf (OCS) Oil and Gas Leasing Program. The plan includes opening the entire Atlantic Ocean from Maine to Florida for drilling including all of the Jersey Shore and NY's South Shore and would allow rigs to come within 3 miles of beaches.



Address comments to Secretary Zinke in one of two ways:

Drilling will:

- Harm or kill marine life
- Pollute our clean ocean economy
- Increase climate change through burning fossil fuel
- Run dry, leaving an oily, dirty mess for our future

Widespread Offshore Oil Drilling Opposition



On January 4th, Trump opened 90% of U.S. ocean waters to proposed drilling in the new draft OCS 5-year drilling plan. Reaction from elected officials was swift and furious, and is growing. Over 35 US Senators and over 130 US Representatives in Congress oppose the plan—including 100% of the NJ congressional delegation. Nearly every state Governor (including Murphy and Cuomo) on the Atlantic and Pacific (except Maine and Georgia) have opposed the proposed offshore drilling plan, and have demanded the "Florida exemption" to be removed from further consideration. While Florida is officially still under consideration, Secretary Zinke has promised that it will be removed in the future.

NJ unites in leadership and action gaginst Trump's new proposed draft 5-year Outer Continental Shelf Oil and Gas Leasing Program.

Blizzard of opposition: Within 24 hours of announcement, and following a snowstorm, NJ leaders join then Governor Elect Murphy to oppose the plan.

COA Visits the Shrewsbury River Maintenance and Beach



The dredged slurry of 90% sand is pumped through pipelines and is temporarily held in a sludge dewatering zone on the beach so that it can dry and be suitable for placement as beach fill.

NJDOT explained the dredging operation in the river and associated activities. The dredging, which takes place each day for a total of 12 hours, is continuously monitoring by the onsite crew.


