DEEMED TO CONSTITUTE A THREAT TO THE ENVIRONMENT AND AMENDING
AND SUPPLEMENTING CHAPTER 17 (SOLID WASTE MANAGEMENT) AND
MANDATORY RECYCLING THE CODE OF THE BOROUGH OF AVALON, 2013

WHEREAS, the Borough Council intends to amend and supplement the Code of the Borough of Avalon for the reasons and in the manner hereinafter set forth;

NOW, THEREFORE, BE IT ORDAINED BY THE BOROUGH COUNCIL, the Governing Body of the Borough of Avalon in the County of Cape May and State of New Jersey as follows:

Section 1. Ordinance No. 779-2018 heretofore adopted and codified at Chapter 17, Sections 17-6 et seq. of the Code of the Borough of Avalon, 2013 is hereby amended and shall hereafter provide as follows:

17-6 USE OF POLYSTYRENE/PLASTIC FOAM AND SINGLE-USE PLASTIC PRODUCTS PROHIBITED

17-6.2 DEFINITIONS

Unless otherwise expressly stated, whenever used in this chapter the following terms shall have the meanings set forth below:

The following definitions shall be added to the list of definitions and shall be inserted after the definition of "Person" and before the definition of "Polystyrene/Plastic Foam"

"PET" or "PETE" see "Polyethylene terephthalate"

"Polyethylene terephthalate" (sometimes written poly(ethylene terephthalate)), commonly abbreviated PET or PETE, is the most common thermoplastic polymer resin of the polyester family and is used in fibers for clothing, containers for liquids and foods, thermoforming for manufacturing, and in combination with glass fiber for engineering resins. PET consists of polymerized units of the monomer ethylene terephthalate. PET is commonly recycled, and has the number "1" as its resin identification code (RIC). [PET is highly recyclable and many products are now made from these recycled PET plastics. Recycled polyester fabric (rPET) can be made into other product including reusable grocery bags.] (Ord. The definition of "Reusable carryout bag" shall be amended to provide as follows:

"Reusable carryout bag" means a carryout bag that is specifically designed and manufactured for multiple reuse, and meets the following criteria:

Except as herein modified, all other definitions contained in Ordinance 779-2018 shall remain unchanged.

17-6.5 DISPOSABLE FOOD SERVICE WARE

a) All Food or Grocery Establishments and Food Providers within the Borough of Avalon utilizing disposable food service ware shall use recyclable or compostable products, subject to the provisions of §§ 17-6.7 and 17-6.8, with the exception of straws which cannot be made of plastic or compostable **plastic**. (Ord. No. 789-2019)

AMEND (b) to delete "upon request of the customer" and to provide as follows:

- b) All Food Providers may give straws, lids, cutlery, and to-go condiment packages provided that all such items are made of recyclable or compostable materials that are accepted as such by the Cape May County Municipal Utilities Authority, with the exception of straws which cannot be made of plastic or compostable plastic. (Ord. No. 789-2019)
- a) All Borough of Avalon facilities utilizing disposable food service ware shall use products that are recyclable or compostable with the exception of straws which cannot be made of plastic or compostable **plastic**. (Ord. No. 789-2019)
- b) Borough of Avalon Contractors and events promoters utilizing disposable food Service ware shall use recyclable or compostable product with the exception of straws which cannot be made of plastic or compostable **plastic** while performing under a Borough of Avalon contract or permit. (Ord. No. 789-2019)

17-6.9 ENFORCEMENT AND PENALTIES

Amend (a) to delete "issuing fines" to "issuing complaint" and to provide as follows:

- a) The Police Department and Code Enforcement Officer have primary responsibility for enforcement of this chapter. The Police Department and Code Enforcement Officer are authorized to take any and all other actions reasonable and necessary to enforce this chapter, including, but not limited to, investigating violations, issuing **complaints** and entering the premises of any business establishment during business hours. (Ord. No. 789-2019)

Amend (c) to delete the term "civil" and to provide as follows:

- c) Any business establishment that violates or fails to comply with any of the provisions of this chapter after a written warning notice has been issued for that violation shall be subject to a penalty that shall not exceed Two Hundred (\$200.00) Dollars for a first violation; Three Hundred Fifty (\$350.00) Dollars for a second violation within any twelve (12) month period; and Five Hundred (\$500.00) Dollars for each additional violation within any twelve (12) month period. Every thirty (30) days that a violation continues will constitute a separate offense. (Ord. No. 789-2019)

<u>SECTION 5.</u> SEVERABILITY. If any section, paragraph, subdivision, subsection, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, subsection, clause or provision declared invalid and the remainder of this Ordinance shall remain in full force and effect and shall be enforceable.

<u>SECTION 6:</u> EFFECTIVE DATE: This Ordinance shall take effect on and after June 1, 2019 upon final adoption and publication as required by law.
