COA conducts research on plastics, pathogens, and chemical pollution by engaging citizen science with rigorous oversight by the PhD staff scientist. Research is coordinated with state and federal agencies, as well as with outside scientists to ensure quality.

CITIZEN ACTION

COA acts as a watchdog by responding to and investigating calls from citizens about polluting activities. Action campaigns, including meetings and rallies to inform the public and record testimony, petitions and letter-writing campaigns, are prepared with scientific technical and legal expertise to ensure protection of marine water quality from pollution, including from pathogens, chemical, and marine debris.
