COA acts as a watchdog by responding to and investigating calls from citizens about polluting activities. Action campaigns, including meetings and rallies to inform the public and record testimony, petitions and letter-writing campaigns, are prepared with scientific, technical and legal expertise to ensure protection of marine water quality from pollution, including from pathogens, chemicals, and marine debris.
