



C.O.A.S.T. INTERNSHIP – CITIZEN ACTION OUTREACH **Summer 2022 Announcement**

This full-time C.O.A.S.T. Internship with Clean Ocean Action (COA) is an exciting opportunity for a student interested in policy, advocacy, and environmental stewardship to help protect and improve the ocean. The intern will gain experience in public relations, outreach, marketing, and grassroots organizing as part of a citizen action program for ocean advocacy. This summer program to inform and involve the public is called C.O.A.S.T. (Clean Ocean Action Shore Tips). This year, it will focus on COA's efforts to reduce pollution and stop ocean industrialization.

C.O.A.S.T. is held in cooperation with organizations, businesses, beach clubs, and shore communities. During the summer information/action tables staffed by COA volunteers are set-up at beaches, parks, municipalities, businesses, and events along the coast. Information is provided to the public on how individuals can make a difference in the quality of NJ's coastal waters.

The C.O.A.S.T. Intern will be responsible for organizing all aspects of the C.O.A.S.T. program.

Specific Responsibilities

(In consultation with Advocacy Campaign Manager and Education Coordinator)

- ◆ Research and become familiar with policy issues for the C.O.A.S.T. program
- ◆ Secure tabling and outreach opportunities at beaches, parks, towns, festivals, businesses, and events
- ◆ Coordinate educational materials and retail merchandise for information/action tables
- ◆ Train and coordinate volunteers who will staff the tables
- ◆ Engage people and organizations in advocacy actions
- ◆ Coordinate media activities, including press conferences related to C.O.A.S.T.
- ◆ Assist with fundraising and resource development

Qualifications

- Pursuing degree in Policy, Communications, Environmental Studies or other relevant field
- Comfortable working with volunteers
- Experience with outreach, advocacy, marketing, and media
- Experience conducting research
- Proficient in Excel and other MS products
- Strong organizational skills and attention to detail

By the end of the internship, C.O.A.S.T. Intern will have:

- Stay conversant and current on COA priorities and programs
- Assist with updating relevant COA materials, fact sheets, and write monthly newsletter articles
- Be flexible to help on any project at any time, as needed

Time and Location Requirements

The summer internship is a full-time position and is generally located at COA's office in Long Branch, NJ. **It is essential to the success of the program and the overall internship experience that the applicant lives within close proximity to the Long Branch office to sustain daily commuting.** No housing or transportation is provided. Official office hours are 9am to 5pm, Monday – Friday, and sometimes longer. Attendance at some evening and/or weekend meetings and/or events may be necessary. Willingness and ability to travel throughout Monmouth and Ocean County, work nights (if needed), and to be “on call” on weekends is required. Flexibility is available for excessive hours when necessary. The position requires a reliable car and the ability to pack and deliver supply bins. Office protocols will adhere to all NJ and CDC guidelines, and COA's office status; applicants must be fully vaccinated.

Business casual attire is expected and can vary depending on activities. Monthly stipend and travel expenses (excluding commuting) are paid. College credit (arranged by the student with the university/college) is available. Start date is as early in May as possible and end date is as late in August as possible.

Interested applicants should demonstrate enthusiasm and basic knowledge of environmental issues, organizational and communication skills, creativity, and willingness to work hard, as well as live within close proximity to the COA office.
