Founded in 1984, COA brings together and empowers over 115 organizations, hundreds of businesses and thousands of citizens to protect nature's most important resource: the ocean. The professional staff includes a PhD and an attorney. The small and effective team applies research, education, and citizen action to reduce pollution and impacts from climate change with fact-based campaigns to implement environmentally-sound solutions.

ACCOMPLISHMENTS: Significant improvements to marine water quality by reducing sources of pollution, plastics, and climate change, including:

- \* ended ocean dumping of eight ocean dumpsites off the coast of NJ
- \* blocked ocean industrialization, including seven Liquefied Natural Gas facilities
- \* passed the nation's strongest state law prohibiting offshore oil and gas activities with support from 99% of NJ legislature
