Friend of Our COAlition: Marine Mammal Stranding Center



Stationed in Brigantine, NJ, the **Marine Mammal Stranding Center** (MMSC) helps distressed marine life such as seals, whales, dolphins, and sea turtles. Founded by Robert Schoelkopf and his wife Sheila Dean over 30 years ago, the small band of dedicated staff and volunteers has responded to over 3,900 strandings throughout New Jersey and beyond. Each year, MMSC offers outreach programs, group tours of the barrier island region, summer camps, internships, and volunteer training programs. Clean Ocean Action's (COA) staff are trained first responder volunteers for sightings and strandings of marine life.

"The MMSC has been looking after whales, dolphins, and sea turtles for 30 plus years, but we depend on COA to look after the ocean that these animals live in," said **Bob Schoelkopf**, **MMSC Co-Director**.

MMSC is the only center responding to strandings in New Jersey. The center collects scientific data on the distressed or deceased animals. Such data can often act as an indicator of poor water quality and a warning sign for the swimming beaches in New Jersey, enjoyed by visitors and locals alike.

Unfortunately, federal funding (called the Prescott Grant Program) for this important center, and others like it, is in danger of being cut (see article, page 2).

LNG is Back! Port Proposed in the Ocean

The company Liberty Natural Gas, LLC, filed an amended application changing the location of their proposed liquefied natural gas (LNG) port to roughly 30 miles off Monmouth Beach, New Jersey, and 19 miles south of Jones Beach, New York. It was originally proposed to be located off Asbury Park, NJ. This new location is farther from New Jersey and closer to New York, and in the middle of an area currently under consideration for the already-proposed Long Island-NYC Offshore Wind energy collaborative.

The issue of LNG ports ties closely to the debate on shale gas and hydro-fracturing. With the US's LNG import facilities operating at less than 10% import capacity (and falling), these ports across the country are applying to switch from imports to exports. COA maintains that the proposed Liberty LNG port could become a spigot through which gas produced from regional shale gas formations will be exported abroad.

New Jersey Governor Chris Christie says he is opposed to this project – no matter the configuration of its pipelines. Liberty LNG cannot escape the legal rights of coastal governors, such as Christie, by moving closer to the people of the South Shore of Long Island, NY.

Help Save Swimmers from Sewage



Response to the elimination of funds for the "Beach Water Quality Monitoring Program," are swift and strong. President Obama's proposed budget for US Environmental Protection Agency's (EPA) Fiscal Year 2013 zeroed-out funding for this program which provides grants to states to monitor water quality at beaches. It also requires states to notify the public when water quality exceeds applicable national standards. New Jersey receives about \$280,000 and New York receives over

\$350,000 for beach monitoring each year. Without funding, testing programs will be significantly cut back. The national program costs less than \$10 million, and protects millions of citizens from becoming sick from polluted water. These cuts will endanger the health of the millions of people who use our nation's beaches and the \$61.5 billion coastal tourism and recreation economy.

COA is working with congressional leaders to urge Congress and the President to restore funding for the Beaches Program and to protect public health and ocean waters. A bi-partisan letter to a US Senate budget subcommittee requesting the restoration of funding for the program was initiated and signed by US Senator Lautenberg (D-NJ) and signed by Senators from NJ and NY -- Menendez (D-NJ), Schumer (D-NY), and Gillibrand (D-NY) -- as well as Senators from other states. Also, in a bi-partisan letter to a Congressional Appropriations Subcommittee, seven US Representatives, led by US Rep. Pallone, Jr., (NJ-D-6) requested to restore funding for this important program to the 2012 level of \$9.9 million. The six other Representatives signing this letter were: LoBiondo (NJ-R-2), Capps (CA-D-23), Bilbray (CA-R-50), Castor (FL-D-11), Bishop (NY-D-1), and Blumenbauer (OR-D-3).

Organizations from the Pacific, Atlantic, Gulf of Mexico, Great Lakes, and the Great Plains also joined COA in fighting to restore these vital funds.

Grassroots action is well underway. Over 60 organizations signed a letter circulated by COA and over 6,500 individuals messaged their Congressmen through Surfrider Foundation's online system urging support for the Beaches Program. See COA's website for a link to this online action system.

Working to Save NOAA Lab at Sandy Hook & Marine Mammals

As reported last month, US President Obama's proposed FY13 budget closes the James J. Howard NOAA (National Oceanic & Atmospheric Administration) Marine Sciences Lab on Sandy Hook, and scraps federal funding for centers that respond to stranded marine mammals.

The proposed closure of the lab prompted strong bi-partisan action from NJ Congressional members. A letter was organized by US Reps. Pallone (NJ-D-6) with LoBiondo (NJ-R-2), and signed by Reps. Rothman (NJ-D-9), Runyan (NJ-R-3), Andrews (NJ-D-1), Smith (NJ-D-4), Sires (NJ-D-13), Holt (NJ-D-12), and Pascrell (NJ-D-8). It asks the Congressional Appropriations Committees to restore funding for the NOAA lab.

In addition, Rep. LoBiondo (NJ-R-2) signed a letter to **Congressional Appropriations** committees requesting the restoration of funding for the Prescott Grant Program, which provides funds for centers that respond to marine mammal strandings.

Also, a large coalition of environmental organizations, recreational and commercial fishing groups, and civic organizations rallied to bring attention to marine lab and cuts to the funds that help stranded marine mammals. More than 30 groups (see box) sent a letter to the President requesting the lab remain open and funds maintained for the Prescott Grants. To view the federal letters, go to COA's website.

Mind the New Fertilizer Law and Be a Bay Buddy



Barnegat Bay is polluted with an excessive amount of nitrogen, a primary ingredient in lawn-care fertilizers. As a result, the Bay's unique ecosystem is dying. COA and Save Barnegat Bay urge Ocean County homeowners to take the Barnegat Bay Buddy Challenge, a stewardship program in which citizens earn points by taking actions that will reduce the pollution entering the bay.

In 2010, NJ passed the nation's toughest fertilizer law which will reduce the amount of pollution entering the bay, as well as all other waterways in the state. New Jersey is the first state to limit both the nitrogen and phosphorus content in all lawn-care fertilizer products sold at retail. The law will regulate the use of these fertilizers by consumers and professionals. The law also prohibits fertilizer application from November 15 to March 1, or when the ground is frozen (special restrictions apply to professional applicators). The law ensures that all lawn care providers applying fertilizers must be certified. For information about NJ's Fertilizer Law go to www.snyderfarm.rutgers.edu/njfertilizerlawguide.html.

New Jersey's law is now a national model and is planting the seeds for many other states in regards to fertilizer laws and regulations. Though all regulations go into effect by 2013, consumers should ALWAYS monitor content labels, follow directions accordingly, ensure their lawn-care providers are certified, and ultimately consider best management practices on their properties to avoid the use of fertilizer.

By becoming a Barnegat Bay Buddy, individuals will identify and accomplish small steps that will keep their yards healthy without the use of fertilizers. Barnegat Bay Buddy applications are online or can be downloaded at www.CleanOceanAction.org. Certified Bay Buddies are awarded an attractive yard medallion to highlight your "bay friendly" status.

Unwrapping Your Boat? Recycle the Shrink Wrap



COA encourages boat owners to use reusable covers for their boat. However, if you must use plastic shrink wrap, the New Jersey Sea Grant Consortium (NJSGC) and the NJ Department of Environmental Protection (NJDEP) have a Shrink Wrap Plus Recycling Program. Nine counties were awarded funding to develop effective and efficient methods to collect, bale, and recycle boat shrink wrap: Atlantic, Burlington, Cape May, Cumberland, Middlesex, Morris, Ocean, Sussex, and Union. Marina owners and boaters should contact their County Recycling Coordinator to find out more about shrink wrap collection and drop off options and locations.

The NJSGC has an extensive education and outreach program to explain the benefits of recycling shrink wrap and other materials to marinas, boaters, municipal officials, and county recycling coordinators. Several fact sheets are available for distribution at www. njcleanmarina.org (click Shrink Wrap Plus Recycling Program).
