



COA, Oceana Turn Up the Volume Against Seismic Testing

On Monday, September 16th, Clean Ocean Action, Oceana, Sierra Club New Jersey, and the Sandy Hook Sea Life Foundation held a forum at Monmouth University to educate the public and turn up the volume about seismic air gun testing. The practice of seismic testing - or blasting air cannons in the mid-Atlantic Ocean in search of oil and gas deposits - is being proposed by the federal Bureau of Ocean Energy Management (BOEM). After a number of public hearings in early Spring of 2012 - one of which in Atlantic City was attended by ocean advocates from across New Jersey - the decision on whether or not to allow seismic blasts has been postponed twice.

The event hopes to keep up pressure on the federal government and increase public involvement on the issue.

Congressman Pallone is a national champion on the issue. He has led the charge against seismic testing in Congress by authoring a letter to the White House urging the Department of Interior to decide against the testing. He opened the event and said that, "Seismic testing is the first step to offshore drilling, and we have to put a stop to it." Earlier this year, Congressman Pallone also stated that, "Already New Jersey's coastal economy is reeling from the devastation of Superstorm Sandy, and our fishing and tourism industries need to be protected from further challenges to their economic and environmental well-beina."

The panel was moderated by Monmouth University's Urban Coastal Institute Director, Tony MacDonald, and included Nancy Sopko from Oceana, Jessica Coakley from the Mid Atlantic Fisheries Management Council (MAFMC). and COA's Executive Director Cindy Zipf. All three panelists described their opposition to seismic exploration and their skepticism that looking for oil in the Atlantic is necessary. COA also advocated for the Clean Ocean Zone and keeping the ocean wild and industry free. The progress made in the NY/NJ bight should be locked-in and pollution locked-out.

Take Action on Port Ambrose!

Now that the public comment period has closed for Liberty's Port Ambrose offshore LNG Facility, it is up to us to make sure that the Governors of New York and New Jersey know how many of their constituents oppose the project. Make your voice heard in opposition to LNG offshore. Call Governor Cuomo or Governor Christie and urge them to veto Port Ambrose.

Legislative Candidates Meet the Public, Answer Questions on LBI

As a part of the Waves of Action September Series, Alliance for a Living Ocean, Clean Ocean Action and ReClam the Bay hosted an environmental forum with the Republican and Democratic candidates of New Jersey's 9th Legislative District. In attendance were incumbent Republican candidates Senator Chris Connors, Assemblyman Brian Rumpf, and Assemblywoman Diane Gove along with the Democratic challengers for the Assembly seats, Mr. Peter Ferwerda, and Mr. Christopher McManus.

Moderated by Rick Bushnell of ReClam the Bay, the discussion allowed the candidates to answer questions pertaining to environmental issues locally, state-wide, and nationally. Many candidates' positions about issues were similar, with all candidates opposing offshore LNG, and exploration for oil and gas offshore.

The discussion turned to the importance of protecting Barnegat Bay and more importantly, getting the public and decision makers to realize their responsibility and role with the problems that plaque the Bay.

Environmental education was raised as an important method that not only incorporates science and research, but allows the public to learn about the impact of their everyday decisions and how they affect their local and global ecosystems.

All candidates agreed that municipalities don't have the funds needed to address environmental concerns, and that the Department of Environmental Protection needs stricter enforcement of some environmental regulations.

On Saturday, September 21, volunteers gathered at the Spring Lake Pavilion to build rain barrels for their homes. A rain barrel collects water when it rains from the roof gutter's downspout and holds about 50 gallons of water which can be used to water your landscape and non-food gardens. Ten barrels were made – which will harvest 500 gallons every time it rains. The effort was part of the Wreck Pond Action Plan and hosted by NJDEP. Wreck Pond Stormwater Education Committee and Clean Ocean Action. By disconnecting your gutter from the stormwater system, rain barrels help to alleviate the stormwater pollution that enters our streams, Wreck Pond and the ocean. Rain Barrels are just one way to be a part of the solution to the stormwater pollution affecting our waterways! The Wreck Pond Stormwater Committee Takes a Tour

COA co-led a walking/talking tour of Wreck Pond with Eileen Eilenberger,

who chairs the Wreck Pond Stormwater Education Committee and is from Spring Lake Heights. The Corps of Engineers, NJDEP, and town representatives and consultants provided information on water quality projects and flooding issues and answered citizen questions. Inlet changes and living shoreline options are being evaluated. Some wastewater and stormwater infrastructure problems have been identified in Spring Lake; temporary and long-term repairs are being made. The importance of slowing down and soaking in rain water to the ground was emphasized. The tour highlighted the beautiful rain garden installed by the Garden Club of Spring Lake and Rutgers Cooperative Extension.
