



Fish Research

COA's Coastal Policy Attorney recently attended a 3 day marine science course to learn more about fish science and management, and connect with commercial and recreational fishermen and women who are passionate about the ecosystems. The workshop covered a wide array of topics ranging from how scientists determine the age of a fish and survey the mid-Atlantic, how commercial and recreational landing numbers are incorporated into stock assessments, and ever more pressing, how we can determine the ways in which fish and fishing grounds are changing due to ocean warming.

Two things became very clear from this workshop; first, there is much common ground among all types of ocean users who depend upon a clean and

functioning marine environment. While COA does not work on fisheries issues directly, our focus on marine water quality and prevention of offshore industrial activities supports healthy ecosystems and the fish that depend upon them. When the ocean is clean and harmful-industry free, we all win. Second, the workshop makes clear that continued investment from State, Federal, and Local entities in science and research for our marine ecosystem is critical in understanding the health of fish stocks, as well as the greater marine ecosystem. A changing climate and all types of human uses are changing our cherished blue world. It is critical that we invest the time and money to understand the extent and pace of these changes.

EPA Citizen Science Public Forum

U.S. EPA Region II hosted the second Citizen Science Public Forum on Jan 09, 2017 in New York City. The event was well-attended by federal and state officials, nonprofits, and citizen scientists. Dr. Swarna Muthukrishnan, Staff Scientist, represented COA. Judith Enck, EPA Region II Administrator opened the session with her remarks about how citizen science is one of the primary ways of moving forward in identifying and solving environmental issues of concern. The main areas of focus for citizen science efforts are water and air pollution issues in Region II and in the Caribbean. Region II provides technical support to citizen scientists and also analytical support through its Equipment Loan Program. Guest presentations showcased citizen science success stories in water quality monitoring involving high school students, and real time air quality mapping and monitoring initiatives. A round-table discussion of different groups brain-stormed on three important questions: (i) Key challenges faced by citizen scientists; (ii) How can citizen scientists focus efforts and maximize the impacts of our work?; and (iii) How can EPA be most effective in supporting citizen science-based initiatives? It was an informative meeting, which provided an opportunity to interact with peer-groups working on water quality issues in the NY/NJ area. The forum also helped gain an insight into various EPA resources that can be used to further COA's citizen science program agenda.
