

# NJDEP Extends the Decision Date on the NESE Pipeline

The three year battle over the health of the Raritan Bay drags on as Williams/Transco and the New Jersey Department of Environmental Protection (NJDEP) mutually agreed to extend the deadline for a decision on the offshore pipeline by 30 days. The DEP now has until October 25 to make a decision on the offshore portion of the project. COA urges everyone to take the following steps to help save the bay and ocean: (1) Keep calling Governor Murphy at least once per week and tell him to Say NO to NESE – (609) 292-6000, (2) Keep writing to the Governor and tell him why he must deny NESE at https://nj.gov/governor/contact/all/, (3) Sign the petition online at CleanOceanAction.org, and (4) Write a letter to the Editor of your local paper explaining what is at stake.





# Citizens Rallied Against Fossil Fuels in Red Bank

On Friday September 20, three days before the UN Climate Summit in NYC, citizens across the US and world attended strikes to demand action be taken to address the climate crisis. COA spoke at the Red Bank Climate Strike at Riverside Park in Red Bank, NJ on ocean acidification, sea level rise, and actions citizens can take to reduce their individual carbon emissions.

This month marked a significant milestone in the effort to protect our ocean from the dangers of offshore oil and gas developments. Congress passed both HR 1941 by Rep. Joe Cunningham (D-SC) and HR 205 by Rep. Francis Rooney (R-FL). The bills would permanently ban offshore drilling off the Atlantic, Pacific, and Florida Gulf coasts. Both bills passed with strong bipartisan support. New Jersey along with several other Mid-Atlantic and New England states passed both measures unanimously, highlighting the regions bi-partisan commitment to protecting the coastline.

## **Diamondback Terrapins in the Two Rivers**

Attendees of last month's Rally for the Navesink meeting had the chance to meet their neighbors – diamondback terrapins! Mike Haughwout, a science teacher at Rumson Fair Haven High School who leads the school's Project Terrapin program, shared information about their effort to protect terrapins in the Navesink and Shrewsbury Rivers. Right now. RFH Project Terrapin's research focuses on understanding population densities, nesting sites, and road crossings for the local terrapin populations. COA took this opportunity to update attendees on the progress of the Rally

### **Delaware Debris**

Marine debris may seem most visible at the Jersey Shore, but it is crucial to remember that marine debris often starts out as inland litter that is carried to our waterways through stormwater runoff. COA's Delaware Sweeps initiative brings the Beach Sweeps model to locations in need along the Delaware River to address these land-based sources of litter.



On September 15 COA hosted a clean-up at the Trenton Public Boat Ramp with members of the Lambda Theta Phi fraternity from The College of New Jersey.



On September 12 COA hosted a Delaware Sweep at the Rivergate Boat Ramp in West Deptford. Students from Professor Jessica DeGraff's Marine Biology class at Rowan College at Gloucester County participated and collected 1,747 pieces of debris; over 90% of the debris was plastic.

# Students Act to Oppose NESE

As students across the nation and the world take actions to fight climate change, students from the Holy Cross Academy in Rumson, NJ, took local action to "Say No" to NESE. Led by Holy Cross teacher MaryJane Gallo, students in grades 6-8 sent over 70 letters to NJ Governor Murphy urging him to deny the permits for the proposed NESE pipeline project. As party of a language arts lesson, the students researched the NESE project and listened attentively to and asked key questions at a presentation by COA's Cindy Zipf and Kari Martin at their school. The letters were mailed to the Governor's office on September 16. Overwhelmingly, the student cited environmental and climate change concerns as reasons to reject the project.
