Offshore Wind: Too Much, Too Fast. Make Your Voice Be Heard.

According to the National Marine Fisheries Service (NMFS), by 2030 the Northeast marine ecosystem will be occupied by over 2.4 million acres of offshore wind (OSW) energy leases (twice the size of Grand Canyon National Park), 3,400 turbines (as tall as the Chrysler Building), and 10,000 miles of submarine

cables (the distance from LA to NYC 3 ½ times) with an additional 5.7 million acres under review for development. Thirty OSW projects are in process from MA to NJ. Also, there are up to 50 substations, up to 30 stories high, awaiting construction.

COA supports reasonable and responsible renewable OSW energy; however, the current scope, magnitude, and speed of the industrialization is unprecedented with little to no due diligence to identify, understand, avoid, and address consequences. Studies on marine life are lacking, incomplete, or inconclusive. Cumulative impacts are largely ignored.

And yet, the NJ Board of Public Utilities (NJBPU) is seeking to expand NJ's OSW projects, opening calls for projects which could double current projects. This expansion adds to the extremely reckless pace without good science, due diligence, and governance to ensure the protection of marine life.

In March, COA's Cindy Zipf testified as an invited witness at a Congressional Hearing on Offshore Wind Industrialization in Wildwood, NJ, hosted by Rep. Jefferson Van Drew (R-NJ-2) and attended by US Reps. Chris Smith (R-NJ-4), Andy Harris (R-MD-1), and Scott Perry (R-PA-10) (see COA's website to read COA's testimony). To ensure OSW is reasonable, responsible, and protective of marine life, COA continues to call for a comprehensive, scientific, independent, peer-reviewed pilot study of the true costs and benefits, and risks and returns of offshore wind.

Good News on Reducing the Plastic Plague in NJ

On May 4, 2022, the "Single-Use Waste Reduction Act," which bans plastic bags and foam take-out containers, and limits straws, went into full effect. After just 5 months, the NJ Food Council estimated that 3.44 billion plastic bags and 68 million paper bags were eliminated from the waste stream. Progress was also evidenced by the 2022 Beach Sweeps data with these three bad litter actors (plastic bags, straws and foam containers) declining on local beaches by over 35% (see story page 4).

COA's Cindy Zipf chairs the Governor-appointed New Jersey Plastics Advisory Council (PAC) which was created by the law to monitor, assess, and evaluate implementation and effectiveness of the law and to identify additional measures to reduce plastic waste through reduction and recycling. On May 4, 2023, the PAC released the First Year Report highlighting the success of the law and outlining future steps.

To get at the larger issue of waste, Senator Smith recently introduced a bill to reduce packaging waste. The "Extended Producer Responsibility" or "EPR" bill (S.426) puts the burdens of packaging material collection and disposal on the companies producing the materials - not municipalities, and reduces packaging to save money and resources.

Unprecedented Numbers of Whales & Marine Mammals Washing Ashore NY-NJ

As you may have heard, a grim record of dead whales have stranded in the NY-NJ region since December last year, as well as many dolphins. In early January, with whale number five, COA began to evaluate what might be different. Shipping, fishing, and beach replenishment activities reflect previous years; however, pre-construction survey vessels for offshore wind projects (OSW) were unusual. COA's Kari Martin investigated and found the National Marine Fisheries Service (NMFS), which is required by law to protect marine mammals, had issued Incidental Harassment Authorizations (IHA) to an unprecedented 11 companies, allowing them to "take" 63,820 marine protected

species including whales, dolphins and seals. The vessels use sonar, boom-Photo Credit: Current Media Company ers and sparkers, all of which can harass these animals by causing them to stop feeding, breathing, nursing, migrating, and other vital activities. NMFS also lists increased vessel strikes from OSW as threats to marine life, but there are no known limits to the number of vessels working in the same region simultaneously. COA believes OSW surveying to be a plausible cause in the whale deaths and is taking action.

On January 9, 2023, COA held a press conference, with several groups joining, releasing a letter to President Biden calling for a halt to OSW survey work until an independent, publicly transparent investigation is complete to ensure survey activity is not the cause of the marine mammal deaths. The response from federal agencies was swift to claim "there is no evidence" that the cause is OSW activity; however, they provide no evidence, which is why COA continues to demand an investigation, robust and sound science, and due diligence to prove OSW is safe for the ocean and marine life.

Hundreds came out that cold and windy day to demonstrate their attention to the issue and celebrate these gentle giants of the sea. COA continues to press for an investigation into the cause of deaths.

Thank you to Leslie and Trisha for putting together this great event, to all guest speakers for expressing your concerns, and to all citizens for coming together to demand action to protect the ocean.

Winter Weather Brings Community Scientists Together

We kicked off 2023 with the launch of our Winter Road Salt Monitoring Program The program is a project of the New Jersey Watershed Watch (NJWW), which COA started in 2020 to investigate the impacts of deicing applications on local water quality.

Excess salt from deicing applications can enter our waterways through runoff and negatively impact fish and other wildlife. Community scientists trained by COA brave wintry weather to test waterways in the Two Rivers Watershed for chloride (salt) levels from January to April. This community monitoring effort will help to determine the impacts of deicing and road salt applications on upstream tributaries in the watershed.

COA's Water Quality Team selected 11 locations along the Navesink and Shrewsbury rivers for monitoring. Community scientists will use a field chloride test kit and record the data using an ArcGIS Survey123 Form.

Monitoring these locations over the winter months will help to keep us informed on the general water quality of the Two Rivers Watershed. The data will be shared with state and national programs.

Spotlight on COA's Youngest Community Scientist 2023

Reagan Volk, a High School Senior from Rumson Fair Haven Regional High School, started her volunteer internship with Clean Ocean Action in September 2023.

As a volunteer intern, she spends three weekday afternoons at COA and assists Program staff on different activities. Her primary internship focuses on understanding water quality issues, and she is currently reviewing the recreational water quality of New Jersey beaches using NJDEP's Cooperative Coastal Monitoring Program data. She also got trained by COA staff to conduct road salt monitoring recently and completed her first sampling and monitoring event as a community scientist in our ongoing collaborative study!
